A Better Way to Match Expectant Parents with Adoptive Parents



ADOPTMATCH is a mobile app that connects Expectant Parents pursuing an adoption plan with Adoptive Parents committed to creating child-centered and ethical adoptions. AdoptMatch is not an agency, attorney or facilitator. AdoptMatch is the first-ever mobile app that gives Expectant Parents access to a wide range of homestudy-approved Adoptive Parents throughout the country, with the oversight of an experienced Adoption Professional.

HOW ADOPTMATCH WORKS

EXPECTANT PARENTS



Expectant Parents download the free AdoptMatch app on their mobile device and browse to find Adoptive Parents who share their values.



When an Expectant Parent finds an Adoptive Family she likes, she submits a Request for More Information about the family and receives a response from the family's Adoption Professional within two business days.



The Adoption Professional reaches out to the Expectant Parent to connect her with the Adoptive Family.



After learning more, if the Expectant Parent is still interested, she connects directly with the Adoptive Family through the Adoption Professional.

ADOPTIVE PARENTS



Adoptive Parents download the app, create a profile, and submit a request to become an AdoptMatch Family.



Once their profile is received, AdoptMatch verifies the Adoptive Parents' affiliation with an Approved Adoption Professional and confirms that their homestudy is current.



The AdoptMatch profile is approved, activated and ready to be viewed by Expectant Parents on AdoptMatch.



When an Expectant Parent finds an Adoptive Family she likes, she will have the option to connect with the Adoptive Parents' Adoption Professional to find out more information about them. The Adoption Professional will initiate their usual intake process and notify the Adoptive Parents of a potential match.

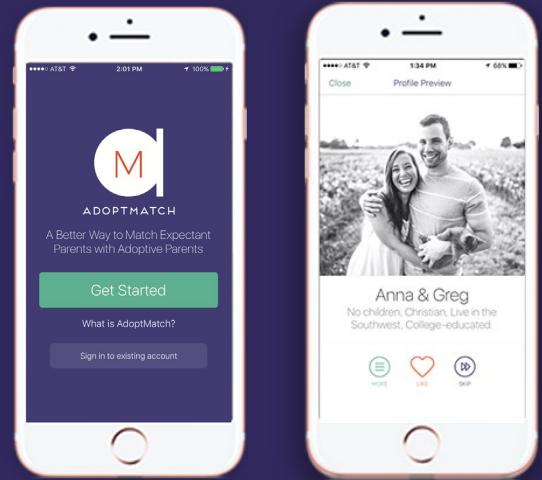

OUR GUIDING PRINCIPLES
